

## “Autumn Campaign” PROMOTION

### TERMS AND CONDITIONS

1. Instructions on how to participate, the prize and gifts form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. **Offer not valid in conjunction with any other offer.**
2. Entry is only open to Australian residents aged 18 years or over. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
3. Promotion commences for purchases on 01/04/2022 and closes at 11:59pm AEST on 30/05/2022 (“Purchase Period”). The claim and entry period commences 01/04/2022 and closes at 11:59pm AEST on 13/06/2022 (“Claim/Entry Period”).
4. To be eligible to enter, individuals must spend, in a single transaction, \$189 (including GST) or more on Tefal product/s (excluding Jamie Oliver by Tefal products) from an Authorised Retailer nationally during the Purchase Period (“Qualifying Transaction”). An Authorised Retailer is any retailer that stocks Tefal products and displays advertising material for this promotion (“Authorised Retailer”).
5. Multiple entries are permitted, subject to the following: (a) only one (1) entry permitted per Qualifying Transaction (regardless of the amount spent on Tefal product/s over \$189 (including GST) in that transaction); and (b) each entry must be submitted separately and in accordance with claim requirements.

To enter, individuals must then visit <https://www.tefal.com.au/specialoffers>, follow the prompts to the promotion entry page, input the requested details (including their full name, address and email address), upload a copy of the purchase receipt for the Qualifying Transaction and submit the fully completed entry form during the Claim/Entry Period.

#### **Gift Offer**

6. In addition to an entry into the prize draw (clause 14), every valid entry received in accordance with clause 5 above will be awarded the gift of a Tefal Ice Force Chef Knife 20cm (K2320214) valued at RRP\$99.95.

Upon submitting a valid entry, entrants will be notified by e-mail that their entry has been deemed received. At the end of the promotion period, if the entry has been deemed valid, entrant will then receive a single-use Gift redemption code (“Code”) to claim their Gift. Once an entrant has received their Code, they must visit [tefalshop.com.au](http://tefalshop.com.au) and follow the instructions within the email provided to redeem their chosen Gift. Codes are valid for one use only and must be used by 11:59pm AEDST on 31/07/2022. If for any reason the claimant does not redeem their Gift/s by the time stipulated, then the Gift/s will be forfeited.

## **Draw**

13. All valid entries received during the Entry Period will be entered into a draw. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. The winner will be notified in writing within two (2) business days of the draw and their name will be announced online at [www.tefal.com.au](http://www.tefal.com.au) from 17/06/2022.
14. The Promoter's decision is final and no correspondence will be entered into.
15. The first valid entry drawn will win four (4) x \$500 VISA or Mastercard gift card totalling \$2,000 to use within three (3) years from the card issued date.
