

“COOK AROUND THE WORLD WITH TEFAL” PROMOTION
TERMS AND CONDITIONS

1. Instructions on how to participate and gifts form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. **Offer not valid in conjunction with any other offer.**
2. Entry is only open to Australian residents aged 18 years or over. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

To be eligible to enter, individuals must spend, in a single transaction, \$179 (including GST) or more on Tefal product/s (excluding Jamie Oliver by Tefal products) from an Authorised Retailer nationally during the Purchase Period (“Qualifying Transaction”). An Authorised Retailer is any retailer that stocks Tefal products and displays advertising material for this promotion (“Authorised Retailer”).

Multiple entries are permitted, subject to the following: (a) only one (1) entry permitted per Qualifying Transaction (regardless of the amount spent on Tefal product/s over \$179 (including GST) in that transaction); and (b) each entry must be submitted separately and in accordance with claim requirements.
